Executive Committee Meeting

On June 29, 2018, the Executive Committee of the East Bay Community Energy Board met for its fourth meeting. The agenda for the Executive Committee meeting covered the Local Development Business Plan, an overview of Phase 2 marketing activities, update on the award of a BAAQMD grant and general updates on marketing, regulatory and energy procurement.

Update on Opt-Outs

EBCE has experienced 502 opt-outs through July 10 13, 2018. These customers represent 0.90% of EBCEs total Phase 1 accounts and 3.13% of EBCE Phase 1 load.

The one major insight that can be derived from these statistics is that a very small number of large accounts can drive up the percentage of load that is opted-out. Those cities that are listed "n/a" are due to fact that their opt-outs are currently either under fifteen accounts or over fifteen percent of load and are therefore subject to CPUC confidentiality requirements.
