

### Legislative Update

#### Key Deadlines for the 2020 Legislative year:

- 1/6: Legislature reconvened
- 1/10: Governor submitted budget
- 2/21: Bill introduction deadline
- 4/24: Policy cmtes to move fiscal bills to fiscal cmtes (1st house)
- 5/1: Policy cmtes to move nonfiscal bills to floor (1st house)
- 5/15: Fiscal cmtes must move bills to floor (1st house)
- 5/29: Each house to pass bills introduced in that house
- 6/15: Budget bill must be passed
- 6/26: Policy cmtes to move fiscal bills to fiscal cmtes (2<sup>nd</sup> house)
- 7/2: Policy cmtes to move nonfiscal bills to floor (2<sup>nd</sup> house)
- 8/14: Fiscal cmtes to move bills to floor (2<sup>nd</sup> house)
- 8/31: Last day for each house to pass bills
- 9/30: Last day for Governor to sign/veto bills

#### Legislative Update: Next Steps

- Continue to review and analyze new bills
- Monitor existing bills on our watch list
- Monitor Governor's Budget request
  - Climate resiliency: \$12.5B over the next 5 years, incl \$4.75B climate resiliency bond Nov ballot
  - Proposal dedicates \$750M to wildfire prevention and \$250M to community resilience incl investment in microgrids, backup power, and distributed energy resources
  - Climate Catalyst Fund: \$1B prioritized for transportation emission reduction, etc.
- Engage with CalCCA on legislative efforts
  - Collaborate with CalCCA on central reliability bill
  - 3/10 is CalCCA Lobby Day: Opportunity for local elected officials to connect with our Alameda County delegation in Sacramento
