Executive Committee Meeting

Finance, Administration and Procurement Subcommittee Meeting

The Finance, Administration and Procurement Subcommittee meeting was held September 11, 2020 at 3 pm.

Marketing Regulatory and Legislative Subcommittee Meeting

The Marketing, Regulatory and Legislative Subcommittee met on August 6, 2020 and received updates from both the Marketing and Account Services Team and the Policy Team. The meeting scheduled for September 3, 2020 was cancelled. The next subcommittee meeting will be held on Thursday November 5, 2020.

New Staff

Cici Saekow, Senior Manager of Power Resources Contracts and Settlements

Cici joined EBCE's Power Resources Team as the Senior Manager of Power Resources Contracts and Settlements on July 27, 2020. She manages EBCE's long-term contract generation portfolio including renewable energy and energy storage resources. She aims to provide low carbon and cost-effective energy for the community.

Prior to EBCE, Cici was responsible for the contract settlements of PG&E's renewable power purchase agreements with results published in SEC 10-K, ERRA, RPS Plan and other compliance filings. She operationalized PG&E's first electric vehicle rebate program partnering with CPUC and CARB. Cici started her energy career at CAISO working on the market initiative release plan.

Cici holds a MBA, BS in Environmental Economics and Policy and a BA in Psychology from UC Berkeley.

Fall Renewables and Storage RFO Update

EBCE is planning to launch a renewables and storage Request for Offers in Oct/Nov 2020 focused on long-term renewables, storage and large hydro procurement. Eligible projects will be greater than 10MW in size and include both in-state and out-of-state projects.

Marketing and Account Services Update

Joint Rate Mailer and Power Content Label Update

The annual Joint Rate Mailer, required by the CPUC, was sent as email on August 24th and via mail on August 21st. To date there have been no significant variations in the number of customers opting out of EBCE service, while there has been a small spike in customers opting up to Renewable 100.

The Power Content Label (PCL), required by the CEC, is typically sent by October 1st. This year, the CEC has delayed the deadline for mailing the PCL to December 31st. The CEC plans to release the power content template in September.

New Communities Engagement

EBCE staff have been meeting with local staff for the cities of Tracy, Newark, and Pleasanton to outline the next steps in enrolling customers and launching service in these areas. EBCE staff has indicated to city staff that a decision must be made by November 30th if the city wishes to enroll customers in a product other than Bright Choice. This will allow the EBCE board to vote on the request(s) at the December meeting and then staff will finalize customer enrollment notification content and design in January for mailing of the first notice in February 2021. EBCE staff has also provided an initial marketing and outreach plan to each city and is working with city staff to customize the plan to best fit the local population.
