Re: Follow-up to Public Comment, Board meeting March 15, 2023

Thank you very much for taking this brief follow-up to my public comment at last night's Board meeting. I'm not yet practiced enough in using this format to keep my comments short.

Now that the Board has authorized Staff to enter into the contract with Middle River Power, I urge Board and Staff to act in two areas to counterbalance EBCE's symbolic endorsement of gas-fired peaker plants in California.

The first area concerns **Renewable 100**, the more expensive but 100% green level of service EBCE offers its customers. To offset the impression of continued support for fossil fuel use, EBCE can mount an aggressive campaign to encourage customers who can afford it to opt up from Bright Choice. Better yet, it could seek to persuade non-participating member jurisdictions to adopt Renewable 100 as their default, while of course preserving and maybe even increasing financial protections for low-income customers.

Secondly, EBCE could follow a **NEM policy** that continues to incentivize rooftop solar+storage and microgrid development. If the CPUC does not reverse its new NEM3 proposal, EBCE should devise its own NEM policy.

From my vantage point as a member of CACE, one is struck by the diversity of CCAs throughout California. EBCE is among the largest, but apart from wind generation in the Altamont Pass, it has fewer easily accessible renewable energy resources (eg., geothermal, offshore wind, etc.) than other smaller CCAs. But what EBCE does have that few others do is its huge customer base and extensive built environment and transit hubs. This includes the vast extent of its commercial, municipal and residential (single and multifamily) rooftops. NEM3 proposes to unfairly cut EBCE off from this, its best "naturally occurring" source of renewable energy!

Action on these two fronts would do more for EBCE's public image than a mere change of logo or "brand."
