(1:00) Public Comment: Jessica Tovar, representing the East Bay Clean Power Alliance, expressed concerns about the distribution of bill credits, noting that residential accounts received significantly less than commercial accounts. Tovar asked for transparency in how these credits are allocated and suggested that funds could be better invested in long-term solutions like job creation and resilience hubs.

4. (5:54) Community Advisory Committee (CAC) Member Reappointments and Guide Updates (Informational Item)

Feedback on reappointments and updates to the CAC Guide

- The Executive Committee agreed to allow a six-month grace period for CAC members to re-establish residency if they move out of their service area.
- The Executive Committee agreed on a two-term limit for at-large members, with the possibility of rotation every two years.
- The Executive Committee also decided that at-large seats should rotate through geographical regions to ensure broad representation.

(39:46) Public Comment – Elsa Potter, from the Local Clean Energy Alliance and East Bay Clean Power Alliance, proposed reallocating Ava's \$8.4 million solar billing plan funds to better support low-income customers. She suggested using the funds for a direct install solar program which would be targeted at low-income households and those with high daytime energy use.
