SUBJECT: CSA with Omni Government Relations for State Legislative Advocacy

and Advisory Services

DATE: February 21, 2024

Recommendation

Adopt a Resolution authorizing Ava Community Energy's (Ava's) Chief Executive Officer to negotiate and execute a Consulting Services Agreement (CSA) with Omni Government Relations, LLC (Omni) to provide state legislative advocacy and advisory services to Ava through December 31, 2024, with a not-to-exceed amount of \$115,000.

Background and Discussion

Ava staff met separately with three highly recommended government relations firms in October 2023 to solicit quotes and discuss the firms' background, qualifications, experience, abilities, and proposed approach: 1) Weideman Group, 2) Strategies 360, and 3) Omni. Staff evaluated the strengths and weaknesses of each proposal along with the proposed quote. Staff selected Omni as the best option and recommends Board approval of a one-year contract for state legislative services. Omni rose to the top of the selection pool based on the quality of its personnel, demonstrated competence and successes, existing partnerships and relationships, strategic and tactical insights and capabilities, proposed price, and ability to tailor its strategy and approach to the needs, mission, and goals of Ava. These services would replace those previously provided to Ava by Weideman Group between 2018 to 2023.

Omni is a full-service government affairs firm with years of proven experience shaping some of the state's most pressing public policy issues. Omni was founded by one of Sacramento's leading lobbyists, Mandy Lee, who brings her experience from the

Capitol, private sector, and nonprofit background to bear for the benefit of her clients. He then served four California State Assemblymembers, including three consecutive Chairs of the Assembly Natural Resources Committee, with expansive jurisdiction over issues such as energy, forestry and fire management, mining, land conservation, oil and gas development, and waste management. Dan

gained valuable energy and utility experience as a Deputy Director in the CA Public Utilities Commission's (CPUC) Office of Government Affairs, advising CPUC Commissioners, senior leadership, and the Governor's Office on legislative and budget matters and working closely with legislators, CPUC staff and stakeholders to shape legislation in a manner the CPUC could support.

Dan received a Master's in Public Policy from the Goldman School of Public Policy at U.C. Berkeley and Bachelor of Science degree in Environmental Policy Analysis and Planning from U.C. Davis.

He lives in Sacramento with his wife and son and enjoys keeping up with his son on the playground, playing tennis, hiking, and gardening.

III. SCOPE OF WORK

The Scope of Work described below is hereby included as an integral part of our proposal to ACE. The goal of the activities listed below is to provide you with the most coordinated and seamless service possible in furtherance of the ACE's legislative, budgetary and administrative needs.

- Omni will assist ACE in building and enhancing relationships with key members of the Legislature, Governor's Office, and Newsom Administration and their staff, enabling ACE to raise its profile and influence, improve its credibility, and increase its bandwidth.
- Omni will connect ACE's work with issues and policies that are of interest to the Governor
 and Legislature including climate change, energy reliability, zero-emission transportation and
 charging infrastructure, and distributed energy resources. With a full understanding of the
 breadth of the ACE's assets and initiatives, Omni can help personalize ACE's work both in
 Sacramento and in legislative districts in order to demonstrate ACE's leadership in these areas
 and allow legislators to see how relevant policies are directly impacting their constituents.
- Omni will initially focus on enhancing relationships with ACE's legislative delegation with the goal of ensuring these legislators perceive ACE as a resource and leader in the clean energy space.
- Omni will work with ACE to develop an advocacy and outreach plan, incorporating the above scope and other strategies or tactics to accomplish its legislative, budgetary or administrative needs for the 2024 legislative cycle.
- Omni will help ACE organize advocacy or other trips to Sacramento and schedule meetings with Legislators, the Governor's Office, relevant committee and other staff.
- Omni will electronically track and analyze all introduced legislation and amendments affecting ACE. Omni will provide ACE with custom bill reports containing status, location, and relevant hearing dates.
- Omni will advocate on behalf of ACE in meetings with legislators, testify in committee or budget hearings, and assist in drafting or finalizing position letters, legislation and amendments as directed by ACE.
- Omni will provide ACE updates on legislation, the state budget, political trends, and electoral and other information relevant to ACE during regular check-ins and an annual strategy retreat.
- Omni will keep ACE apprised of key proposals and developments at agencies such as the CA
 Energy Commission, CA Air Resources Board, and others as directed by ACE, and introduce
 ACE to relevant appointees and staff at these agencies.

IV.

FEE SCHEDULE

Omni Government Relations proposes to meet the full range of legislative advocacy services work described above in the Scope of Work section. For this agreement, we suggest a monthly retainer fee set at Ten Thousand Dollars (\$10,000) per month.

Extraordinary business expenses, such as air fare and hotel accommodations or other travel shall be reimbursed with prior approval from ACE. Omni's retainer will be billed monthly by a written invoice to the contract administrator.

RESOLUTION NO. R-2024-XX

A RESOLUTION OF THE BOARD OF DIRECTORS OF AVA COMMUNITY ENERGY AUTHORITY AUTHORIZING THE CEO TO NEGOTIATE AND EXECUTE A CONSULTING SERVICES AGREEMENT WITH OMNI GOVERNMENT RELATIONS, LLC

WHEREAS The Ava Community Energy Authority ("Ava") was formed as a community choice aggregation agency ("CCA") on December 1, 2016, Under the Joint Exercise of Power Act, California Government Code sections 6500 et seq., among the County of Alameda, and the Cities of Albany, Berkeley, Dublin, Emeryville, Fremont, Hayward, Livermore, Piedmont, Oakland, San Leandro, and Union City to study, promote, develop, conduct, operate, and manage energy-related climate change programs in all of the member jurisdictions. The cities of Newark and Pleasanton, located in Alameda County, along with the City of Tracy, located in San Joaquin County, were added as members of Ava and parties to the JPA in March of 2020. The city of Stockton, located in San Joaquin County was added as a member of Ava and party to the JPA in September of 2022. The city of Lathrop, located in San Joaquin County, was added as a member to Ava and party to the JPA in October of 2023. On October 24, 2023, the Authority legally adopted the name Ava Community Energy Authority, where it had previously used the name East Bay Community Energy Authority since its inception.

WHEREAS Ava would be benefited by assistance from Omni Government Relations, LCC (Omni) for legislative advocacy and advisory services, both to represent Ava's views on bills in the new legislative cycle as well as to provide legislative advocacy and advice around any bills that Ava may choose to sponsor. Omni would facilitate countless meetings in Sacramento, in district and remotely, and support Ava in developing relationships with legislators and their staff, as well as with administration officials and other key strategic partners.

WHEREAS Ava staff solicited quotes from three advocacy firms, and Omni was selected due to the quality of its personnel, demonstrated competence and successes, existing partnerships and relationships, strategic and tactical insights and capabilities, proposed price, and its ability to tailor its strategy and approach to the needs, mission, and goals of Ava.

WHEREAS From 2018 to 2023, Ava contracted with the Weideman Group, Inc. for these services. In 2023, the not-to-exceed for this contract was \$125,000.

WHEREAS The contract with the Weideman Group, Inc. expired on December 31, 2023, and Ava now needs new legislative advocacy and advisory services.

NOW, THEREFORE, THE BOARD OF DIRECTORS OF AVA COMMUNITY ENERGY AUTHORITY DOES HEREBY RESOLVE AS FOLLOWS:

<u>Section 1.</u> Ava's Board of Directors hereby authorizes Ava's Chief Executive Officer to negotiate and execute a Consulting Services Agreement with Omni to provide state legislative advocacy and advisory services to Ava through December 3' 2024, with a not-to-exceed amount of \$115,000.
