2. Public Comment

(0:54) Audrey Ichinose sought clarification on East Bay Community Energy's engagement with legislative and CPUC matters especially regarding important bills and bill authors. Ichinose expressed concern about the CPUC's proposed decision on new net energy metering tariffs, stating that it could harm rooftop solar users and urged CCAs like Ava to take a stance on the issue.
