## **Executive Committee Meeting**

A meeting of the Executive Committee was held on November 6, 2024. Members received updates on the SMUD Contract Extension and on the Resilience Hub Initiative Technical Assistance program. The next Executive Committee meeting will be held on Wednesday, December 4, 2024 at 9am.

### Marketing, Regulatory and Legislative Subcommittee Meeting

The October 18, 2024 Marketing, Regulatory and Legislative Subcommittee Meeting was canceled. The next MRL meeting will be held on Friday, December 20, 2024 at 12pm.

## **Community Advisory Committee Meeting**

On October 15, 2024, Ava's Community Advisory Committee (CAC) had a productive, in-person 'meet & greet' and strategic planning session with Ava staff. This provided an opportunity for CAC members to 1) meet one another and Ava staff; and 2) identify key priorities that will be featured in the Committee's updated Work Plan for 2025 and beyond. The next Community Advisory Committee meeting will be held on November 18, 2024 at 6pm.

### Financial, Administrative and Procurement Meeting

The November 13, 2024 Financial, Administrative and Procurement did not achieve a quorum. Staff presented an informational session with Director Andersen, reviewing our financial audit, budget comparison, on-bill credit distribution, and Critical Municipal Facilities Program. The next meeting of the Financial, Administrative and Procurement Subcommittee will be held on March 12, 2025 at 1pm.

# **Health-e Communities launch**


The Health-e Communities program was launched in early October. The pilot program provides the free installation of an induction range along with air quality monitoring directly before and after installation. The goal is to install 200 induction ranges in Ava customer households for CARE/FERA or affordable housing unit residents. Outreach is being done directly to known CARE/FERA customers with early efforts already producing 70 applications. Our installation partner, Franklin Energy is performing site assessments to determine that there is adequate electrical support for the installation. ## Fremont R100 Opt-up and R100 Cost Allocation Methodology update

On July 17<sup>th</sup>, 2024, the Board approved the Fremont City Council's request to default most customers within the City to Renewable 100 (R100). Fremont's default rate transition is currently scheduled to be implemented as follows: 1) Residential customers in August 2025; and 2) commercial/industrial customers in August 2026. Bright Choice will remain the default option for those on customer discount programs such as CARE/FERA and Medical Baseline. Since there are no changes or impacts to the Bright Choice discount or Renewable 100 premium (the Ava Value Proposition) in our current fiscal year 2024-25, if needed the Renewable 100 Cost Allocation Methodology discussion will take place in the spring alongside the 2025-2026 Budget. Note that we continue to see material price increases in renewable energy costs going into 2025.

## CCA's have signed over 18GW of Clean Energy Resource PPAs

CalCCA recently announced that CCAs in California have signed 346 long-term power purchase agreements (PPAs), securing 18,285 MW of new clean energy resources, including solar, wind, geothermal, energy storage, and demand response technologies. The agreements represent a record 4,300 MW added in the past year, the largest annual increase to date. CCAs now have 116 operational clean energy projects, over 7,900 MW in total, that serve 14 million customers in California – about 1/3 of the state's population. These projects include diverse energy sources and significant investments in energy storage and are located in 30 California counties, from Humboldt County in the north to San Diego County in the south, as well as in the states of Arizona, New Mexico, Nevada, and Utah. CCAs have committed over \$37 billion to build and operate these resources, supporting more than 36,000 construction jobs. CCAs are also leveraging innovative financing tools to reduce energy costs by up to 10% through energy prepay financing structures. Ava has completed ~\$3bn in energy prepays that are entirely off balance sheet to date.
