C-2025-113 Keyes and Fox (San Francisco)Joint Representation Agreement Keyes and Fox will represent Ava Community Energy, Central Coast Community Energy, CleanPowerSF, Marin Clean Energy, Peninsula Clean Energy Authority, City of San Jose, Silicon Valley Clean Energy, and Sonoma Clean Power Authority regarding PG&E's Application for Approval of its Billing Modernization Initiative.
